PENNINGTON COUNTY BOARD OF COMMISSIONERS Meeting of September 26, 2017

The Pennington County Board of Commissioners met at 9:00 a.m. on Tuesday, September 26, 2017, in the Commission Chambers in the County Administration Building, Rapid City, South Dakota. Chair Deb Hadcock called the meeting to order with the following Commissioners present: Ron Buskerud, Mark DiSanto, George Ferebee and Lloyd LaCroix.

REVIEW AND APPROVE AGENDA

MOVED by DiSanto and seconded by Buskerud to approve the agenda as presented. Vote: Unanimous.

CONSIDERATION OF THE FY2018 PROVISIONAL BUDGET AS THE ANNUAL BUDGET OF APPROPRIATIONS, EXPENDITURES AND REVENUES FOR PENNINGTON COUNTY, SD

A. ANY AND ALL OTHER ITEMS RELATED TO THE APPROVAL OF THE FINAL BUDGET.

MOVED by LaCroix and seconded by Buskerud to reduce the JTV Grant budget by \$60,000 to \$0 until grant is awarded later. Vote: Unanimous.

MOVED by LaCroix and seconded by DiSanto to reduce the HIDTA budget by \$58,745 to match projected revenues in 2018 and add \$58,745 to the Law Enforcement budget to properly show matching expenses. Vote: Unanimous.

MOVED by Hadcock and seconded by LaCroix to increase taxing by \$175,000 and take out of stored CPI and move the reserves up to 17.19% and the levy to a reduction of 4.40.

Substitute motion: MOVED by Ferebee to reduce the General fund budget same as last year plus the growth number. The motion died for a lack of a second.

Original motion failed 3-2 on a roll call vote: Buskerud – no, DiSanto – no, Ferebee – no, LaCroix – yes, Hadcock – yes.

MOVED by LaCroix and seconded by Buskerud to accept the budget as presented. The motion carried 3-2 on a roll call vote: Buskerud – yes, DiSanto – no, Ferebee – no, LaCroix – yes, Hadcock – yes.
